CREW Idaho, Inc. Chapter Membership Types

75% of membership composition, CREW Idaho, Inc. shall consist of:

- A. Full Membership: Five (5) years of experience in a “qualified field of commercial real estate” and employed full-time in a professional position, the primary responsibilities of which are in a “qualified field of commercial real estate”.

25% of membership composition, CREW Idaho shall consist of:

- B. Associate: Same qualifications as “Full” member but has less than five (5) years of experience.
- C. Vendor: Does not qualify for “Full” member status, but admission furthers the purposes of the chapter and benefits its members. A Vendor member must be employed full-time in a position (number of years of experience is not a factor), the primary professional responsibilities of which relate to, benefit or support commercial real estate and supplies a service or physical product related to commercial real estate. (Ex. Roofing, carpeting, landscaping, painting, office furniture, janitorial services, etc.)
- D. Civic: Involved in local or regional government, other public agencies, universities or other educational institutions or not-for-profit organizations, who may or may not meet primary responsibility or experience requirements, but admission furthers the purposes of the chapter and benefits its members.
- E. Retired: CREW Network member no longer working full-time, but who wants to remain involved in the chapter and connected to members.
- F. Student: Enrolled full-time in an undergraduate college or university program. Pursuing education intended to lead to a career in a commercial real estate field.

* Individuals qualifying for membership in the special categories of Civic, Retired, and Student are not counted against either the 75% or 25% membership ratio requirements. These individuals are approved outside of the membership total requirements set by CREW Network.
