### QUALIFICATIONS FOR SCHOLARSHIP AWARD

1. Must be a female applicant.
2. Must be currently enrolled in a qualifying field of real estate, must have at least one term remaining in a course of study leading to a degree or an associate degree in a real estate related field. High school students are not eligible.
3. Must be enrolled full-time in a school located in the state of Idaho.
4. Applicant must desire a career in a Commercial Real Estate field.
5. Must be currently enrolled and in good standing at an Idaho College or University as a Freshman, Sophomore, or Junior in a Bachelor's Program, or as a Senior accepted into a graduate program, or a Graduate student in any of the following majors/disciplines focused on a career in Commercial Real Estate, including, but not limited to:

6. Overall GPA of 3.0 or better – need to submit latest transcript, at minimum a printout of your cumulative transcript from your school's website.
7. GPA in Major of 3.0 or better – need to submit latest transcript, at minimum a printout of your cumulative transcript from your school's website.
8. Two (2) Letters of Reference from any two of the following sources:
  - a. From a professor in the applicable major;
  - b. From a current or past employer not related to you; and
  - c. From a personal source that has known you at least 5 years.

Applicant is responsible for ensuring that all items listed below are submitted to CREW Idaho by May 15, 2019

- d. Completed and signed Application Form
- e. Transcript of grades for three most recent semesters.
- f. Cover letter explaining career plans, employment history, financial need, and extracurricular activities. (limit 2 pages)

Applications will be reviewed, and winners selected by the CREW Idaho Scholarship Committee. All applicants will be notified of their status after May 31, 2019

Select applicants may be subject to a personal interview with a CREW Idaho representative.

Recipients of scholarships are required to provide proof of registration and payment receipts before funds are released directly to the student.
